

Checklist for adult representation

Austria - Status: October 2025

Adult representation is the form of legal support that has been in place in Austria since 2018 for adults who are temporarily or permanently unable to make decisions for themselves. Its aim is **self-determination rather than representation**: Support (information, assistance) is provided first, and representation is only provided where necessary – as **sparingly** as possible and **for a limited period of time**.

There are four forms of legal representation:

- **Power of attorney**: The person affected takes action in advance of an impairment and determines the own care. Depending on the issue, several people can also be appointed. The power of attorney is registered in the Austrian Central Representation Register (ÖZVV). The power of attorney only takes effect when the person is no longer capable of making decisions.
- **Elected adult representation**: In this case, it is assumed that the person is still cognitively capable of choosing a representative on their own. The person chooses a representative for specific matters as long as they still have the ability to understand the nature of a power of attorney. It is unlimited in time and becomes effective as soon as it is entered in the Austrian Central Representation Register (ÖZVV). It can be terminated at any time by the person represented.
- **Legal adult representation:** In this case, close relatives take on the representation (e.g. parents, children, grandchildren, siblings). It comes into effect upon registration in the ÖZVV and is limited to a maximum of three years.
- **Court-appointed adult representation** is only used if the forms of representation listed above are not possible.

All forms of representation are limited to **specific tasks**. The power of attorney, elected adult representation and legal adult representation are **registered** in the ÖZVV (with a notary, solicitor or adult protection association) and can be adjusted or terminated – so that the person affected retains as much **decision-making power** as possible.

In the case of **court-appointed adult representation**, an application is made to the court stating that this form of adult representation is necessary. In a second step, an adult protection association is commissioned to clarify the appointment procedure (known as clearing orders). As part of the clarification process, the person concerned is visited in order to gain an impression of the living situation. Furthermore, an analysis is made of the support options available in the environment. **Legal adult representation** is only recommended if there are no other options.



In 2025, there were decisive changes that were heavily criticised by adult protection associations:

- The maximum duration of legal adult representation has been extended from 3 to 5 years (the maximum duration of statutory adult representation remains three years).
- Once a court-appointed adult representation has expired, there is no longer any obligation to clarify the requirements for adult representation. An application for clarification must be submitted to the court in a renewal procedure, which then decides whether to commission an adult protection association to carry out the clearing process.
